

ORDINANCE NO. 016-219

AN ORDINANCE LEVYING PERSONAL PROPERTY, AND PROPERTY OF PUBLIC SERVICE COMPANIES AD VALOREM TAXES AND PROVIDING ASSESSMENT, EQUALIZATION AND COLLECTION PURSUANT TO THE PROVISIONS OF KRS 92.280, ET. SEQ.

BE IT ORDAINED, by the City Council of the City of Shepherdsville, Bullitt County, Kentucky as follows:

SECTION ONE: A personal and property of public services companies ad valorem tax of 13.6 cents on each \$100.00 value of all property taxable for municipal purposes, except property assessed by the State, in said City is hereby levied for the year 2016 as of January 1, 2016.

SECTION TWO: Said levy is made for the purpose of raising revenue to pay salaries of officers and employees; for the repair and maintenance of streets, public ways, and public buildings in said city; to pay for lighting city streets; and pay all proper charges and legal demands against the city.

SECTION THREE: The assessment made by the Bullitt County Property Valuation Administrator for State and County purposes for 2016 shall be and is hereby adopted as the assessment for City purposes. The City tax bill shall be made from the county list in the Property Valuation Administrator's books after they have been supervised and corrected by the County Board of Equalization.

SECTION FOUR: The City Clerk shall take the list of all persons subject to City taxation who are not shown on the county Property Valuation Administrator's books and shall add to the City Tax Rolls all property a portion of which is in the city where the value of the portion in the city is not shown on the Property Valuation Administrator's books.

SECTION FIVE: These taxes as they relate to motor vehicles and boats shall be collected by the Bullitt County Clerk as provided by KRS 132.487 et seq. And the City Clerk be and is hereby directed to forward to the Department of Property Valuation, 200 Fair Oaks Lane, Frankfort, Kentucky 40620, a 2016 Motor Vehicle Tax Rate Certification for the year 2016. Any tax bill remaining unpaid for sixty (60) days after the due date as established by the Commonwealth of Kentucky, will be declared DELINQUENT and bear interest at six percent (6%) per annum, or one half (1/2) of one percent (1%) per month or a fraction thereof until paid; and in addition thereto, a penalty of ten percent (10%) of the amount for general purposes shall be added for non-payment when due.

SECTION SIX: With respect to personal property and property of public service companies (other than boats and motor vehicles), the Bullitt County Sheriff be and is hereby directed to prepare tax bills for all persons and organizations in the City of Shepherdsville, Bullitt County, Kentucky, against whom taxes have been levied. He is hereby directed to notify such persons and organizations by mail that on and after January 1 thru January 31, 2017, any tax bill remaining unpaid will be declared

DELINQUENT and bear interest at five percent (5%) for that period. On or after February 1, 2017 thru April 15, 2017 the interest will be ten percent (10%) plus a ten percent (10%) add on fee. Sheriff shall also indicate that a discount of two percent (2%) will be allowed on bills paid on or before November 1, 2016.

SECTION SEVEN: All payments of taxes, other than boats and motor vehicles, provided for herein shall be made to the Bullitt County Sheriff at P. O. Box 205, Shepherdsville, Kentucky 40165.

SECTION EIGHT: The Clerk is directed to advertise this Ordinance as provided by law.

SECTION NINE: Any Ordinance or parts of Ordinance in conflict with this Ordinance or any part of this Ordinance is hereby repealed.

SECTION TEN: Should any section, clause, line, paragraph, or part of this Ordinance be held unconstitutional or invalid for any reason, the same shall not affect the remainder of this Ordinance.

Given first reading at a special meeting of the City Council of the City of Shepherdsville, Bullitt County, Kentucky, on the 15th day of September 2016. Given second reading, voted upon and passed at a special meeting of the City Council of the City of Shepherdsville, Bullitt County, Kentucky on the 16th day of September 2016.

ORDINANCE NO. 016-220

AN ORDINANCE ESTABLISHING THE REAL PROPERTY AD VALOREM TAXES AND PROVIDING ASSESSMENT, EQUALIZATION AND COLLECTION PURSUANT TO THE PROVISIONS OF KRS 92.280, ET SEQ.

BE IT ORDAINED, by the City Council of the City of Shepherdsville, Bullitt County, Kentucky, as follows:

SECTION ONE: A real property ad valorem tax of 13.9 cents on each \$100.00 value of all real property taxable for municipal purposes in said City is hereby levied for the year 2016, as of January 1, 2016.

SECTION TWO: Said levy is made for the purpose of raising revenue to pay salaries of officers and employees, for repair and maintenance of streets, public ways, and public buildings in said city; to pay for lighting city streets; and pay all proper charges and legal demands against the city.

SECTION THREE: The assessment made by the Bullitt County Property Valuation Administrator for State and County purposes for 2016 shall be and is hereby adopted as the assessment for City purposes. The City tax bills shall be made from the county list in the Property Valuation Administrator's books after they have been supervised and corrected by the County Board of Equalization.

SECTION FOUR: The City Clerk shall take the list of all persons subject to City taxation who are not shown on the county Property Valuation Administrator's books and shall add to the City Tax Rolls all real property, a portion of which is in the city, where the value of the portion in the city is not shown on the Property Valuation Administrator's books.

SECTION FIVE: The Bullitt County Sheriff be and is hereby directed to prepare tax bills for all persons and organizations in the City of Shepherdsville, Bullitt County, Kentucky, against whom taxes have been levied. He is hereby directed to notify such persons and organizations by mail that on and after January 1, 2017 any tax bill remaining unpaid will be declared DELINQUENT and bear interest at five percent (5%) for that period. On or after February 1, 2017 thru April 15, 2017 the interest will be ten percent (10%) plus a ten percent (10%) add on fee. Said Sheriff shall also indicate that a discount of two percent (2%) will be allowed on bills paid on or before November 1, 2016.

SECTION SIX: All payments of taxes provided for herein shall be made to the Bullitt County Sheriff at P. O. Box 205, Shepherdsville, Kentucky 40165.

SECTION SEVEN: The Clerk is directed to advertise this Ordinance as provided by law.

SECTION EIGHT: Any ordinance or parts of ordinance in conflict with this Ordinance or any part of this Ordinance is hereby repealed.

SECTION NINE: Should any section, clause, line, paragraph, or part of this Ordinance be held unconstitutional or invalid for any reason, the same shall not affect the remainder of this Ordinance.

Given first reading at a special meeting of the City Council of the City of Shepherdsville, Bullitt County, Kentucky, on the 15th day of September 2016. Given second reading, voted upon and passed at a special meeting of the City Council of the City of Shepherdsville, Bullitt County, Kentucky on the 16th day of September 2016.
