BUCKMAN STREET AND BISHOP LANE IN THE CITY OF SHEPHERDSVILLE, BULLITT COUNTY, KENTUCKY, ALSO KNOWN AS PARCEL 036-SE0-06-004, FROM B-2 BUSINESS TO R-3 RESIDENTIAL BASED ON THE FOLOWING FINDINGS OF FACT:

Ms. Dozier explained that to avoid any confusion that she recommends the Council take a Motion to Deny vote on any rezonings that are rejected. She also recommended the Council to consider physical, social, and economic issues when they are presenting their findings of facts. Finding of facts:

Does not meet the Comprehensive Plan, traffic, flooding issues, there has not been any physical, social, or economic change to alter the future map plan.

Mr. Hibbard brought up that many other rezonings did not meet the Comprehensive Plan and the way the property is zoned the owners could build a strip mall there that would also cause traffic and flooding issues.

Ms. Enlow stated that she did not think there would be as much traffic with a commercial business versus 80 condos being built there.

Mr. Hibbard commented on the concern of affordability, and he does not think the Council should regulate how citizens invest their money. He also addressed the floodplain issue.

Ms. Portman stated that she is concerned about the affordability for the citizens who are on a fixed income.

Mayor Cubero agreed with Mr. Hibbard and asked the Council to keep in mind that the city needs housing and retail.
